DOCUMENTATION REQUIRED TO AVAIL A DESIGNEE OR NEXT OF KIN ACCESS TO A USER'S CYBEREV MINDFILE ACCOUNT:

AS PROOF YOU ARE A CYBEREV USER'S FIDUCIARY REPRESENTATIVE OR DESIGNEE HEREIN NAMED, AND THAT SAID USER EXPERIENCED LEGALLY DEATH OR INCAPACITATION, TERASEM REQUIRES THE FOLLOWING DOCUMENTATION:

A) AN OFFICIAL DEATH CERTIFICATE FOR THE USER. WE CANNOT ACCEPT ANYTHING OTHER THAN A CERTIFIED, GOVERNMENT ISSUE DEATH CERTIFICATE.

PLUS ONE OF THE FOLLOWING DOCUMENTS AS PROOF OF FIDUCIARY RESPONSIBILITY:

- 1) WRITTEN REASON WHY ACCESS TO A USER'S MINDFILE (DIGITAL ASSET) IS REQUESTED;
- 2) A CERTIFIED COPY OF A MARRIAGE CERTIFICATE SHOWING THAT YOU ARE THE USER'S SURVIVING SPOUSE;
- 3) A NOTARIZED OR CONFORMED[∞] COPY OF A WILL OR

[∞] When requesting a **conformed copy**, you can also request that it be **certified**. This means the court or government agency providing it guarantees that the document is a true and exact **copy** of the original. The

TRUST DOCUMENT NAMING YOU AS EXECUTOR/TRIX OR COURT APPOINTED ADMINISTRATOR/TRIX; OR

- 4) A CERTIFIED, NOTARIZED OR CONFORMED COPY OF A BIRTH CERTIFICATE FOR THE USER (IF YOU ARE THEIR PARENT, OR GUARDIANSHIP PAPERWORK FOR LEGAL GUARDIANS).

B) IF THE USER IS INCAPACITATED, A CERTIFIED DOCUMENT SIGNED BY THE MEDICAL PROFESSIONAL IN CHARGE OF THE USER'S CARE. A NOTARIZED NOTE SIGNED BY THE DOCTOR IN CHARGE WILL SUFFICE, AS WILL A SIGNED COURT DOCUMENT SHOWING THAT YOU HAVE POWER OF ATTORNEY OR ARE A TRUSTEE OF A TRUST FOR THE MINDFILE USER; OR

C) A COPY OF THE REQUESTOR'S GOVERNMENT ISSUED, PHOTO ID.

EXAMPLES OF DOCUMENTS TERASEM WILL NOT ACCEPT:

- A. AN OBITUARY;
- B. A CORONER'S INTERIM DEATH CERTIFICATE;
- C. A CORONER'S STATEMENT OF INQUEST INTO A DEATH; OR
- D. A FUNERAL DIRECTOR'S STATEMENT OF SERVICES PERFORMED.

INFORMATION A DESIGNEE OR NEXT OF KIN WILL NEED TO KNOW ABOUT THE USER'S MINDFILE

TERASEM REQUIRES ANSWERS TO ALL OF THE FOLLOWING QUESTIONS REGARDING THE USER'S MINDFILE:

- 1) THE USER'S MINDFILE NAME(S);
- 2) THE DATE OF BIRTH THE USER GAVE WHEN CREATING THE MINDFILE; AND
- 3) THE CITY, STATE, AND ZIP CODE (FOR U.S. USERS) OR COUNTRY THE USER PROVIDED AS HIS/HER PLACE OF RESIDENCE WHEN THE
